| Bergen JCC/Y | 605 Pascack Rd., Washington Twp. NJ 07676 (201)-666-6610 www.yjcc.org GSP- North exit 168. Bear right off exit. Continue to light. Right onto Pascack Rd. "J" 1/4 mi. on left, a big brick building. |
| MetroWest JCC (West Orange Facility) | 760 Northfield Ave., West Orange, NJ 07052 (973)-736-3200 www.jccmetrowest.org GSP exit 145 (280W) to exit 10 (Northfield Ave.). Stay in left on exit ramp. At light turn left, continue 3 miles, "J" on left. <i>Alternate directions:</i> 24 West to exit 7C (JFK PKW to Livingston/Caldwell), Left @ fork on to CR 648 N for 3.8 mi., Right on E. Northfield (508) 1.5 miles to JCC. |
| Middlesex JCC | 1775 Oak Tree Rd, Edison, NJ 08820 (732)-494-3232 www.jccmc.org GSP exit 131, make a right. Go to Wood Ave., make a right. First light, make a left onto Oak Tree Rd. 3/4 mi. facility on left. <i>Alternate route:</i> from Scotch Plains JCC, Cooper Road to Left onto Rahway Road, Left on Inman Ave, Right onto Grove Ave, (quick left then right to stay on Grove), Left on to Oak Tree Road, JCC/YMCA Community Center on right. |

Clinton Ave., Tenafly, NJ 07670 (201)-569-7900 www.jccotp.org GSP North exit 161, Rt. #4E Exit @ " Grand Ave/Englewood " Grand Ave. changes to Engle at 1 mile, pass Englewood Hospital. Make a Right @ 2 nd light past hospital onto E. Clinton Ave. "J" 1 mile on left. <i>Alternate route:</i> (or from GSP South, exit 163, RT 17S, Rt 4E then follow directions above). |
| Raritan Bay Area YMCA | 365 New Brunswick Avenue, Perth Amboy, NJ 08861 (732) 442-3632 www.rbaymca.org GSP South to US-9 exit to I-287/Woodbridge/Perth Amboy/US-440. Take New Brunswick Ave. exit and turn left onto New Brunswick Ave. Stay on New Brunswick Ave. for approx. 1 mile. YMCA is on right. |
| Union YM/YWHA | 501 Green Lane, Union, NJ 07083 (908)-289-8112 www.unionymywha.org GSP North exit 140 to 82E Morris Ave., 6th or 7th light make right (ScherringPlough on left) onto Green Lane, pass Kean University through trucking district. YHA on left. |
| Bridgewater JCC | 775 Talamini Rd. Bridgewater, NJ 08807 (908)-725-6994 www.ssbjcc.org <u>From the East</u> Take Rt. 22 West to (right turn onto) Country Club Rd. (2nd traffic light after Rt. 202/206 intersection) Go through one traffic light, pass the Methodist Church on your left, and make right turn onto <u>Talamini Rd</u> . Proceed 0.7 miles. Go through barricade and turn left onto first driveway, which is the JCC (After Rt. 287 overpass) <u>From the North</u> Rt. 287 South, exit 202/206 Pluckemin. This brings you to 202/206 North-- stay to the right. Take jug handle, which will take you to 202/206 South. Turn Right at 3rd traffic light (Burnt Mills Rd). Left onto Country Club Rd. (1 mi.). Continue on approx. 3 mi., left onto <u>Talamini Rd</u> . Follow above directions. |

Go 0.7 miles; turn right onto RT 31 on facility on right. <i>Alternate:</i> 78 West exit for Rt 31 South, proceed 7.8 miles, turn left onto HealthQuest Blvd. |
